# **Executive Directors Report: James Emery**

Travel report: Environmental Review training in Denver, Colorado on October 10-13, 2016. -organizing and a breakdown of what the review files/assessment under environmental review. We are in the process of making files for each category.

Housing Matters in Salt Lake City, Utah on October 17-20, 2016. The focus was on Homelessness. The biggest cause for homelessness is evictions and the process of it.

Travel plans: NAIHC Leadership Institute – NTCCP-NAHASDA Low Income Tax Credits in Las Vegas, Nevada on November 7-11, 2016

Animal Policy: Pet letters were sent out to 18 residents on October 4, 2016 and the deadline to answer in on October 14, 2016 which is (10) calendar days. So far 14 tenants have complied and a follow up home visit will begin in a week.

Indian Peaks' DPP program and the trailer use issue: there is no update information at this time

#### **New Business**

Corrina Bow – Tribal Chairwoman presented her letter addressed to the Board of Commissioners. RE: Indian Peaks Band's Drug Elimination Request. The letter states, in the future, if Housing or Bands want the Tribal Council's approval or support, all pertinent information needs to be presented to them during an official meeting at the beginning of the process. Rose Black read the letter to the Board.

Organizational Chart for next meeting, and will be looking at the maintenance trucks and the building to see the improvements. Spraying for other homes, we will need to look into setting up a budget or if the bands will pay for the spraying and that a group of homes per area will decrease the cost of the spraying.

## **Emergency & Crisis Assistance (Emergency Assistance Home Repair)**

The program will be called Emergency & Crisis Assistance and will be out of the Non-Program funding with a budget of \$6,000 and a minimum of \$1,500 for assistance. The Board revised the program and will be reviewed for final approval for the next meeting in November 2016.

### **Commissioner's Report:**

Travis Duran was excused at 2:00 pm.

**Shivwits DPP Report:** Band meeting was held on October 6, 2016. The next meeting will be on November 3, 2016. Travis gave an update on the DPP. Program is good and they have a Halloween Party planned.

**Cedar DPP Report:** Band meeting was held on October 5, 2016. The next meeting is on November 9, 2016. The tutoring program is running good and their Annual Spook Alley is open to the public for one night only on October 28, 2016.

**Indian Peak DPP Report:** Band meeting was held on October 6, 2016. The next meeting will be on November 3, 2016. Jeanine provided pictures and the student's trip reports for the Youth Group Council that traveled to Washington DC.

**Koosharem DPP Report (absent):** No report was given at the time of meeting but a report was submitted later that day. The Koosharem Band had their health fair on October 15, 2016. They had 116 people attend, 41 medical screening and 45 dental screening were done. They had a total of 23 vendors that participated. They did a survey and the event was rated excellent.

**Kanosh DPP Report:** Band meeting was held on October 9, 2016. The next meeting will be on November 13, 2016. The DPP has 10 students on the program and they officially opened their program on October 3, 2016. Tutoring is temporarily held in the Band building. The band requested housing to spray their DPP trailer inside and out before they can use it.

Halena updated her band on the new changes on the DPP program and handed out the DPP budget and the DPP policy to the Band council. Tribal members are also inquiring about the vacant homes in Fillmore. She informed them to complete a housing application.

They have scheduled their Halloween Party on October 29, 2016.
