Shivwits Land Corporation deeded it to the Shivwits Band Paiutes Indian Tribe of Utah, I have looked into the corporation and it did not exist in Utah, these deeds were prepared by Jeff Zander former employee of the Paiute Indian Tribe of Utah. I will be looking into this, but Shivwits Band should be the one to be working on the land lease with their attorney.

We will leave 5 rental units on land lease and removed 13 units.
