Follow up on the Paiute Indian Tribe of Utah Health Department on renting the main floor of the old Housing Building for a dentist office and eye clinic. The main floor is 32 cents a square foot at 1,683 sq. ft. will be \$538.00, need to look into a property/lease agreement to be drawn up including any type of remodeling to the building, repairs if needed after the remodeling, who will be responsible for the cost. First and last month rent payment at \$1,200.00 and monthly rent of \$600.00 and a yearly lease agreement.

IHP \$1,720,000 estimate formula for 2018, 2017 final budget review for next board meeting will need to increase the budget because of the expenditure cost. 2019 IHP she will need to be involved in the budget. Cost of living expense for next year 2018 at 2 percent and check with the human resource if this can be done if the employees that have salary increase will not receive the 2 percent.

There are two bids to be sign by Betty Cuch, in the future bids the board has approved for Betty Cuch to sign off, if there are any questions or concerns call us. One concern is the number of change orders they request, this needs to be less, the cost of rehab is at \$50,000 per units.

## **Board of Commissioner Report:**

Cedar Band DPP - band meeting November 7, 2017, no meeting in December and next band meeting will be January 9, 2018, reported on the housing meeting with a report, there was a question concerning preventive maintenance in January and February and not sooner "Why does it occur in January and not before", can this be changed with the maintenance workers for next year

Shivwits Band DPP – band meeting November 9, 2017and next band meeting December 7, 2017, reported to the band members on all the information from the Housing meeting, neighborhood watch signs around the rental units and the DPP trailer, there are about 25 kids attending the program and would like to have additional funding to finish this year. There are issues with travel cost for the tutors or other individuals to voluntary because of the travel distance.

Kanosh Band DPP – no band meeting in November and have not been contacted if there is a meeting scheduled for December, no report.

Koosharem Band DPP- no band meeting in November and next band meeting will be December 9, 2017. The DPP program will be more involved in suicide prevention program and working with tribe and I will be attending the Tall Cop Says Stop. The kids are doing good and the program is also doing good.

Indian Peaks Band DPP – vacant, mail information to them.

Need to look into repairs on the DPP trailers and buildings that the program is being held, if there are any type of funding or if we can use program funding.
