CAVCO homes update, a payment was received on January 26, 2018 for \$4,040.00, but are still behind on the payments.

Land lease agreement was redone and sent to Mr. Jensen to review.

A letter still needs to be sent to the CAVCO homeowners to set up appointment for them to review their payments and balance on their homes.

Old Business:

Tax Credit Update: Resolution 2018-02 Approval of Utah Paiute Tribal Housing Authority (UPTHA) support and authorization to executive a letter of intent with an equity partner for the UPTAH LIHTC Homes #1 Project was tabled

This resolution would hereby authorizes, empowers, and supports the UPTHA to execute a a letter of intent from an equity investor and to furnish the equity investor with all due diligence materials specified by the selected investor in connection with its investment in the partnership; and that the Executive Director and Office Manager authorized, empowered and directed to take such further action on behalf of UPTHA.

Travois will approve to solicit investors to who is going to bring out the highest and the best bid on the job. If there are questions we can address Trent Rodgers to answer all questions on the project. Travois has approved to close the bid to get started on the rehab homes.

Can the board get a list of what Travois will be looking at in investors for the project and when can we apply again for the tax credit, maybe looking in the Washington County area next time.

New Business:

IHP meeting with the Tribal Council went just fine this morning February 18, 2018

There are several policy and procedure that will need to be development for private homes and trailers and for mutual help homes concerning liability, limit of cost to rehab the home or trailer, what can and cannot be done the home or trailer and what type of emergency is emergency (water or gas leaks).

We will check will Bill Nibblelink to see what type of policy and procedure other housing might be using.

Tenants want to know where their late fees are going. We will need to do a report and explain where your money goes.

How housing could get money back from past tenants with debt, looking into selling debt to a collection agency.
